Eija Karsten informed the meeting that it is not possible to circulate the WG report using the new online form before submitting, needed to save and print.

Jolita Ralyté said that space on the new online form is limited for the reporting of events.

The online form is being developed by a student associated with the hosting of the TC8 website.

Action-Item 2020-1: The Chair will work with the student to improve the online form for WG reporting including WG conferences and past events.

Action-Item 2019-3: The Chair will contact George Kasper regarding the amount spent on the Ghana Summer School out of the budgeted funds allocated by UNESCO.

George Kasper was not present to discuss the report. Since some members had not read the report, Dale agreed to email George Kasper's report on the Ghana Summer School for discussion on Day 2.

Action-Item 2019-4: Eija Karsten will follow up the IFIP-AIS liaison initiative with the next AIS president.

- What event can be selected to become a proposal for AIS? (take OASIS as an example of a successful collaboration)
- Task force to work on the details of a proposal

This action item resulted in a quite lengthy discussion. Eija explained that she has now had discussions on

the topic of AIS-IFIP collaboration with AIS President and TC8 National Representative of Ireland Brian Fitzgerald, IFIP General Secretary Eduard Dundler and AIS Fellow and WG9.4 Chair Robert Davison. There is interest in co-locating AIS and IFIP events and sharing some resources such as the AIS registration system and eLibrary. This partnership may be opportune since IFIP has no intention of expanding (although some universities may become members) while AIS is looking to grow. Eija thought that AIS was reputed to be more US-based while IFIP was reputed to be more Europe-based and linked to UNESCO.

Matthew Jones said that past collaborations with AIS had not been particularly effective. This was because the AIS administration system for registrations and financial arrangements had not been satisfactory. There needs to be agreement on how to make the partnership compatible.

Isabel Ramos explained that the benefits to both parties should be considered. Isabel proposed a task force to develop a proposal on AIS-IFIP collaboration. She suggested that Eija lead because of her earlier efforts in this area. Dale offered to assist. In the absence of volunteers, Isabel said she would join the task force. WG 8.2 Organizations and Society in Information Systems OASIS Workshop which had been co-located with ICIS was put forward as a good event to start with.

Action-Item 2020-2: An appointed task force will develop a proposal on AIS-IFIP collaboration.

Action-Item 2019-5: The Chair will continue looking into the business model at the TA meeting.

WG 8.4 Secretary Peter Kieseberg spoke on behalf of Chair Andreas Holzinger. Peter said that the 2020 online conference went really well, with full talks and proceedings. Even social events took place remotely although they had problems obtaining public liability insurance. Peter said that the 2021 conference would be in Dublin at the end of August, co-located with the ARES 2021 conference.

Isabel asked about the issues of conference co-location. Peter thought it was a good idea. He expanded his response to say that the major benefits are sharing costs and the attendance of people from different backgrounds. This allows registrants to go to both / either conference for the same registration fee. ARES is well established while CD-MAKE is an emerging conference. WG 8.4 want it to be a flagship conference showing IFIP as an active research community. Janusz also thought it was a good idea for better social networking so long as not too big an event.

Isabel explained that the term of a WG officer is 3 years. In the WG reports, several WGs including WG 8.4 seem to have terms of 4 years. This reporting of term requires clarification.

WG 8.3 Secretary Biljana explained that the WG election was in June 2020 for a 3 year term. However, the next election is planned for the biennial conference in June 2022 which means a term of 2 years, not 3 years. Ciara and Biljana agreed to follow up with Isabel and Dale.

WG 8.4 Peter thought that the WG election was in January 2020.

Peter will follow up with Chair Andreas and get back to Isabel and Dale.

WG 8.11 No WG officer present to explain.

WG 8.12 Chair Li Da Xu said the situation of his WG was the same with mid-year elections and appointments.

Isabel opened the discussion. Do WGs prefer to specify the term as month and year of appointment eg June 2020, or would it be simpler to have a ruling that the term commenced at the beginning of the year after the election?

Isabel asked for a decision from members present ie specify the month and year when terms commence or commence the term at the start of the year after a WG election as a standard.

All comments were in favour of a term starting in January of the year following the election.

12. Report from the TC8 Chair

TC8 Chair

Analysis of distributed information: Income and expenditure for 2020 and the budgeted income and expenditure for 2021 were presented for approval

Further discussion on income 2020:

The COVID pandemic has disrupted the plans of many conferences – some went from face-to-face (f2f) to online, some were postponed or cancelled. Isabel warned that IFIP funds for conferences are limited hence the need to source additional funding.

WG 8.6 Vice-Chair Amany said that the WG 8.6 Conference in December was in doubt yet 500 euros had been expended. Amany requested that the balance of funds be transferred to 2021.

Action-Item 2020-9: This action item relates to Income 2020. The Chair to confirm -

Further discussion on expenditure 2020:

WG 8.3 Vice-Chair Biljana requested funds from 3,000 euros budgeted for WG website hosting and improvement. Her own organization in Slovenia is purchasing Zoom software. Isabel proposed adding 100 euros per WG to the 2021 budget for the hosting of web services.

Action-Item 2020-10: The Chair to add 100 euros for each WG for the hosting of web services.

WG 8.2 Chair Eija said there were substantial cancellation costs associated with COVID travel restrictions. WG 8.2 paid a deposit of 7,000 euros to the conference centre in Hyderabad and were not refunded when the conference format was changed from f2f to online. Eija asked if it would be possible to obtain a loan from IFIP to compensate for those losses. ¹

Action-Item 2020-11: The Chair to consult Eduard Dundler regarding 2,000 or 2,500 euros in Budget to compensate for conference cancellation costs.

On Day 1 of this meeting, WG 8.2 Chair Eija requested that 4,000 euros allocated to support the attendance of colleagues from developing countries be used to pay for conference registration rather than travel.

WG 8.6 Vice-Chair Amany said the Cape Verde workshop for PhDs in 2020 was moved to an online format. It went well and Internet was not a problem. The budgeted amount of 6,000 euros was not all spent. Amany asked about transferring unspent funds to repay IFIP. Isabel thought this unlikely.

Action-Item 2020-12: The Chair to investigate if unspent conference funds be transferred or reused or refunded.

Isabel raised the issue of WGs trying new conference formats. This has happened to some degree with the COVID disruption to f2f conferences. Isabel spoke of 'coffee tables' simulation to make online meetings less formal. This could be expensive such as 1,000 euros for each licence. AIS has its own conference software.

Action-Item 2020-13: The Chair to investigate new online conference software.
